Motion by Commissioner Johnson, seconded by Commissioner Schultz to refer the correspondence from Oak Glen Wind Farm to the Management & Personnel Committee to draft a letter of support. Ayes all.

Motion by Commissioner Ebeling, seconded by Commissioner Kubicek to place on file the correspondence from the Minnesota County Coroners & Medical Examiners Association. Ayes all.
