



Motion by Commissioner Schultz, seconded by Commissioner Shea to enter into a Grant Agreement for Hazardous Materials Preparedness in the amount of \$3,000.00. Ayes all.

Motion by Commissioner Shea, seconded by Commissioner Schultz to adopt the proposed 2010 Tax Levy in the amount of \$18,598,518. Ayes all.

Motion by Commissioner Schultz, seconded by Commissioner Ebeling to place on file the correspondence from Steele County Soil and Water Conservation District. Ayes all.

Motion by Commissioner Shea, seconded by Commissioner Ebeling to approve the following personnel actions: Susan Callister (Human Services) retirement effective 8/28/09; Amber Aaseth (Public Health) to grade 35/step 12 effective 9/2/09; and Brian Schember (Detention Center) resignation 8/26/08. Ayes all.

Motion by Commissioner Ebeling, seconded by Commissioner Schultz to approve of the following ditch levies: JD 1-3% + interest; JD 5-5%; JD 6-6% + interest; JD 10-12% + interest; JD 11-3%; JD 12-5%; JD 23-10% + interest; JD 24-2.5% + interest; CD 1, Ch Br-20% + interest; CD 2-3% + interest; CD 4-.2%; CD 21-20% + interest; CD 22-10%; CD 23-20% + interest; CD 24-5%; CD 25-18% + interest; CD 27-20%; PTD 8-20% + interest; PTD 9-15% + interest; PTD 17-10%; JD 2-4% + interest. Motion by Commissioner Schultz, seconded by Commissioner Ebeling to recommend County Board directive to Department Heads to reassign job functions/duties and recommend transfers as appropriate to reduce overall personnel costs. Ayes all.

Motion by Commissioner Shea, seconded by Commissioner Ebeling to add a standard condition to all mining permits that "all taxes due shall remain current". Ayes all.

Motion by Commissioner Ebeling, seconded by Commissioner Schultz to approve the \$8 per day fee structure for SCRAM (monitoring system) for Court Services. Ayes all.

Motion by Commissioner Shea, seconded by Commissioner Ebeling to approve the variance from Access Policy for Eugene Larson in Section 20 of Lemond Township, subject to the following requirements: (1) The existing field entrance located approximately 600 feet east of the homestead driveway shall be removed prior to construction of the proposed field entrance; and (2) The permit only grants access as a field entrance. Future change in use will require a separate permit application. Ayes all.

Motion by Commissioner Shea, seconded by Commissioner Schultz to authorize contracting with an attorney specializing in development agreements to review and advise on the proposed Memorandum of Understanding regarding the sale of Heritage Halls property. Ayes all.

Motion by Commissioner Shea, seconded by Commissioner Ebeling to approve of the following listing of bills and Human Services bills in the amount of \$55,259.74. Ayes all.
